This is the definition that already appears in the ALMR Service Level Agreement: "User/Member: an agency, person, group, organization or other entity which has an existing written Membership Agreement with one of the Parties to the Cooperative Agreement. Terms are synonymous and interchangeable." The word is interpreted this way in all ALMR documentation, so I don't know that we should change it in this document?</p> <p>2. Matt can say for sure, but I think that because he couldn't get anyone on the User Council to volunteer for the Secretary role, he looked to the Project Team / Operations Team to fill in the gap - we have and will continue to provide that support. I don't think it is likely that a member will volunteer to be the Secretary - but it is possible. So instead of the Secretary "will" we changed it to the Secretary "may". That way the Charter covers it either way.</p> <p>3. There is a solid line from the EC to the UC on my copy - for some reason it isn't on the one I sent out - I will make sure it's on the final.
